DECISION ON ACCUSED'S REQUEST FOR ADDITIONAL TIME TO PRESENT HIS DEFENCE CASE AND ON MOTION TO RECALL DEFENCE WITNESSES

On 29 October 2013, the Chamber granted in part the Karadžić's motion and allowed him an additional 25 hours to present his case in relation to the reinstated count 1 of the indictment.

ŠEŠELJ case

Judge Agius - Acting President of the ICTY

ORDER ASSIGNING A JUDGE PURSUANT TO RULE 15

On 31 October 2013, Judge Agius assigned Judge Mandiaye Niang to Šešelj case instead of the disqualified Judge Harhoff. Judge Agius also emphasized his opinion that the judges now should consult with the accused whether to rehear the case or to continue the proceedings with the newly assigned judge.

MLADIĆ case

Appeals Chamber – Judges Ramaroson (Presiding), Sekule, Robinson, Pocar and Daqun

DECISION ON MLADIC'S INTERLOCUTORY APPEAL REGARDING MODIFICATION OF TRIAL SITTING SCHEDULE DUE TO HEALTH CONCERNS

On 22 October (made public on 31 October) 2013, the Appeals Chamber ordered the Trial Chamber in Mladić trial to adopt a four-day sitting schedule for the remainder of the Prosecution case and directed it to reassess the matter at the beginning of the Defence case. The Appeals Chamber therefore reversed the Trial Chamber's previous decision rejecting the accused's request for a modified sitting schedule due to his health state.
