DECISION ON THE PROSECUTION MOTION ON BATON HAXHIU'S COMPLIANCE WITH PROVISIONAL RELEASE AND DECISION MODIFYING CONDITIONS OF PROVISIONAL RELEASE

On 19 June 2008, Trial Chamber I modified the provisional release conditions and ordered that Baton Haxhiu shall be allowed to leave his place of residence for the purposes of attending his trial and for the pronouncement of the judgement at a later date. For these occasions, the UNMIK authorities shall return to the accused his passport and re-take it on his return to Priština/Prishtinë.
