Ljubiša PETKOVIĆ Case (“Contempt”)

Trial Chamber III – Judges Antonetti (Presiding), Harhoff and Lattanzi

Judgement

On 11 September 2008, the Trial Chamber found Ljubiša Petković guilty of contempt of the Tribunal by refusing to appear as a Chamber’s witness in the case of Vojislav Šešelj. The accused was sentenced to four months’ imprisonment, credit being given for the three months and 14 days already spent in the Detention Unit.

HARAQIJA & MORINA Case (“Contempt”)

Trial

From 8 - 11 September 2008, the Prosecution and Defence presented their cases to the Trial Chamber. The Prosecution called four witnesses: Protected Witness 1 and Witness 2, Peter Mitford-Burgess (Investigator at the ICTY), and Angelina Krasniqi (employee of the Kosovo Ministry of Culture, Youth and Sport).

The Defence for Morina did not call any witnesses. The Defence for Haraqija called and examined three witnesses, the accused himself, Edmond Kuqi (the accused’s driver), and Agim Kasapolli (advisor to the Kosovo Ministry of Culture, Youth and Sports).

The parties presented closing arguments, and no final briefs will be filed. The judgement will be rendered in due course.
