LAST MINUTE NEWS

KRNOJELAC CASE:

PROSECUTOR TO AMEND INDICTMENT

On 24 February 1999, Trial Chamber II, consisting of Judges Hunt (Presiding), Cassese and Mumba, issued a Decision on the accused's preliminary Motion on the form of the indictment of 8 January 1999. The Motion was granted in part and "[t]he Prosecutor is directed to amend the indictment accordingly and to file and serve an amended indictment on or before 26 March 1999".

KORDIC AND CERKEZ CASE:

PROSECUTION OPPOSES PROVISIONAL RELEASE OF THE ACCUSED

On 22 February 1999, the Prosecution filed its Response to the accused's joint Motion for provisional release of 8 February 1999 (See Update nr. 65). Arguing that "(...) the Defence have not satisfied any of the conditions of Rule 65 to justify the provisional release of the accused", the Prosecution submitted that the Motion should be rejected.

SIMIC & OTHERS CASE:

PROSECUTION OPPOSES VARIOUS DEFENCE MOTIONS

On 22 February 1999, the Prosecution filed its Responses to all Motions, except one, filed by the Defence for Stevan Todorovic on 10 February 1999 (see Update nr. 65). The Prosecution submitted that these Motions should be denied.

On the same date, the Prosecution also filed its Response opposing another Motion by the Defence for Stevan Todorovic of 10 February 1999, in which it was requested that all alias for Mr. Todorovic's name be struck from the indictment.

DEFENCE OPPOSES PROSECUTOR'S MOTION FOR JUDICIAL NOTICE

On 22 February 1999, the Defence for Miroslav Tadic and Milan Simic filed a Response to the Prosecution's Motion for judicial notice of 10 February 1999 (see Update nr. 65). In the Response "(...) the Defence respectfully requests that this Honourable Trial Chamber rejects the Prosecutor's Motion".
