ICTY WEEKLY UPDATE – 235

PROCEDURAL DEVELOPMENTS:

I. OVERVIEW OF COURT PROCEEDINGS:

BRĐANIN and TALIĆ Case (“Krajina”)

Trial Chamber II Section A – Judges Agius (Presiding), Janů and Taya

17th week of the Prosecution case.

On 17 and 19 September 2002, hearings took place on the Defence Request for Provisional Release of General Talić. Representatives of the Federal Republic of Yugoslavia participated in the hearings.

No hearing took place on 18 September.

On 20 September, the Trial Chamber deemed it “appropriate” to order the provisional release of Momir Talić in light of his medical condition (see *Press Release* No. 694). It further decided that the case of the two accused be severed following the conclusion of the testimony of witness Muhamed Filipović. This testimony will resume on Wednesday 25 September 2002.

STAKIĆ Case (“Priedor”)

Trial Chamber II – Judges Schomburg (Presiding Officer) and Vassylenko

20th week of the Prosecution case.

From 16 until 20 September 2002, the Trial Chamber took depositions pursuant to Rule 71 of the Rules of Procedure and Evidence in the absence of Judge Fassi Fihri. Status Conferences took place on 17 and 19 September.
