On 29 January 2003, the Pre-Appeal Judge ordered the Appellant to re-file his Notice of Appeal in accordance with the requirements of Rule 108 of the Rules of Procedure and Evidence and of Article 1 of

the Practice Direction on Formal Requirements for Appeal within 14 days of this Decision. The Judge further ordered that the Appellant file the Appellant's Brief no later than 40 days after the date of filing of the B/C/S translation of the Trial Chamber's Judgement.
