DECISION ON MOTION BY RADIVOJE MILETIĆ FOR ACCESS TO CONFIDENTIAL INFORMATION

On 9 September 2005, the Appeals Chamber, pursuant to Rule 75 of the Rules, granted the “Motion for access to confidential information in the Blagojević and Jokić case” by Radivoje Miletić dated 7 July 2005. The applicant was allowed access, subject to a number of conditions, to all exhibits and decisions classified as *inter partes* and confidential in the Blagojević and Jokić case.

DECISION ON REVIEW OF INDICTMENT AND ORDER SUMMONING THE ACCUSED TO APPEAR

On Friday, 9 September 2005, Judge Orie issued two decisions lifting the confidentiality of the indictments against Josip Jović and Marijan Križić, pursuant to Rule 77 of the Tribunal’s Rules of Procedure and Evidence. He also summoned both accused to appear in a separate order. Josip Jović and Marijan Križić are both charged with one count of contempt of the Tribunal in the case *The Prosecutor v. Tihomir Blaskić* – See Press Release number 1002 dated 12 September 2005.
