On 6 June 2006, pursuant to Article 29 of the Statute and Rules 54 and 65 of the Rules, Trial Chamber II ordered, *inter alia*, that the accused Miletić and Gvero shall return to the Detention Unit no later than Thursday, 29 June 2006.

DECISION ON PANDUREVIĆ'S RENEWED MOTION FOR PROVISIONAL RELEASE

On 6 June 2006, pursuant to Rule 65 of the Rules, Trial Chamber II denied V. Pandurević's request for provisional release until the beginning of the trial, filed on 30 January 2006.
