ORDER SUSPENDING PROVISIONAL RELEASE

On 26 January 2007, pursuant to Article 29 of the Statute and Rules 54 and 65*bis* of the Rules, the Trial Chamber suspended, effective 8 February 2007, the provisional release of the accused Čermak and Markač and ordered that they shall return to the UN Detention Unit to attend the Status Conference on 9 February 2007, which is scheduled at 1600 hours. The order further stated that the suspension shall remain in effect until modified by the Trial Chamber.
